She studied sociology and economics at the Karl Marx University in Budapest, receiving her PhD in 1994 and Habilitation in 2009. She has published widely on the history of the Holocaust in Eastern Europe, memory and remembrance, and Jewish identity in Hungary and Slovakia. She is co-editor of *Modern Antisemitisms in the Peripheries: Europe and its Colonies 1880-1945* (2019) and founder of "Voices of the Twentieth Century" Archives.

Sybille Krämer is Emeritus Professor at the Institute for Philosophy at the Free University Berlin. She is a Guest Professor at the Institute of Culture and Aesthetics of Digital Media, Leuphana University, Lüneburg. She has been a member of the German Scientific Council, European Research Council (Bruxelles), and a Permanent Fellow at the Berlin Wissenschaftskolleg. Her publications include Media, Messenger, Transmission: An Approach to Media Philosophy (2015); with Ch. Ljungberg (eds.), Thinking with Diagrams – The Semiotic Basis of Human Cognition (2016); and, with Sigrid Weigel (eds.), Testimony/Bearing Witness: Epistemology, Ethics, History and Culture (2017).

Fransiska Louwagie completed a PhD in French Literature at the University of Leuven. She was a lecturer and associate professor at the University of Leicester before taking up the position of Senior Lecturer in French Studies at the University of Aberdeen. Ana Belén Martínez García PhD, is Associate Professor at ISSA School of Applied Management, at the University of Navarra, and studied English Philology at the University of Oviedo (Spain). She is a member of the International Society for the Study of Narrative and the International Association of Auto/Biography. Among her publications are articles in a/b: Auto/Biography Studies, Life Writing, Narrative, and the book New Forms of Self-Narration: Young Women, Life Writing and Human Rights (Palgrave Macmillan 2020).

Alan McCully is Honorary Research Fellow at the UNESCO Centre, Ulster University, and before that he was a senior lecturer in Education. Emilie Pine is Professor of Modern Drama at the School of English, Drama and Film at University College Dublin. She has published widely as an academic and critic, most recently *The Memory Marketplace: Witnessing Pain in Contemporary Theatre* (2020), and was Principal Investigator of "Industrial Memories", a project to witness Ireland's historic institutional abuse. Hari Reed holds a PhD in English Literature from the University of Birmingham. Melissa Schuh completed her PhD in English Literature at Queen Mary University of London in 2019 and is a Lecturer in English Literature at Kiel University. She is deputy editor for C21 Literature: Journal of 21st Century Writings.
